



TEXANA MARKET AT BRACKENRIDGE

Vendor Rules and Regulations November 12 - 13, 2010

The Lavaca-Navidad River Authority (LNRA) will lease Vendor/Exhibitor space at the Brackenridge Main Event Center for the Texana Market in conjunction with the Texana Chili Spill Event. The event will be held on Friday, November 12, 2010 from 5:00 p.m. - 10:00 p.m. and Saturday, November 13, 2010 from 9:00 a.m. - 7:00 p.m. The following rules and regulations are in addition to the conditions and costs set forth on the Booth Registration Contract. All spaces are reserved on a FIRST COME FIRST SERVE basis.

1. LNRA reserves the right to prohibit any Exhibit or Vendor/Exhibitor deemed unsuitable for the Texana Market at Texana Chili Spill. This reservation includes any merchandise, product, activity or conduct, and any other things which LNRA deems to be detrimental or inconsistent with the quality, theme or image of the Texana Market.
2. No food or drink items may be sold or distributed freely unless approved in advance by the LNRA.
3. No fundraising activities will be allowed in the booths unless approved in advance by LNRA.
4. All exhibitor/vendors and their employees shall be responsible for any injury or defacing to the building, chairs, and tables.
5. All exhibitors/vendors are responsible for their own exhibits. LNRA will not be responsible for any stolen or damaged items, displays, or equipment. Security will be on site Friday, Nov. 12, 2010 through Sunday, Nov. 14, 2010.
6. Excessive or inconsiderate noise will not be tolerated.
7. All drawings for prizes must be pre-approved by LNRA.
8. Exhibitor/Vendor agrees to duly report all cash sales made during the Texana Market in accordance with the appropriate sales tax regulations.
9. There are no refunds. Also, any checks returned for nonpayment are subject to a \$35.00 fee and booth space will be released.
